HOTELU BULVAR * PARKING REGULATIONS**

1. The Polish Law on Road Traffic (The Act of 20 June 1997) obliges in the area of Hotel Bulvar *** parking lot in Gorzów Wlkp. concerning the law of traffic of mobile vehicles and pedestrians. One-way traffic obliges on the parking area.
2. The speed limit is up to 5 km/h on the parking lot area.
3. The parking lot is secured with a surveillance. The parking service is for an additional cost.
4. The parking is open 24 hrs a day, 7 days a week.
5. The parking area is designed for a mobile vehicles with a weight not exceeding 3,5 tons.
6. A customer using a parking lot, is permitted for a parking in any spot, which is not previously reserved.
7. A mobile vehicle in the parking ought to have the engine and lights off, closed doors, windows, trunk and the optional roof, as well as all the safety systems working (in this specific vehicle model), which secure the vehicle from a burglary or theft.
8. A customer using the parking service leaves the valuables in a vehicle for his or her own responsibility.
9. The owner of the parking is legally responsible for an actual detriment, excluding the lost valuables being a sequence of the incident, from which an aggrieved derives his or her claims. The exception of the lost valuables no longer occurs if a detriment was deliberately caused by the parking owner, his workers or people fulfilling his or her will. Neither does it occur while consumers' rights are evaded.
10. The owner of the parking lot is legally responsible neither for losing, breaking or damaging the vehicle, nor the lost valuables previously remaining in the vehicle, if:
 - a) a person using the parking contributed in an incident, especially, if the security measures, pointed out in sections 2 and 7, were not provided - in a matter of the contribution to the cause and the size of a damage,
 - b) a damage was caused by a force majeure.

Collecting a parking ticket means accepting the parking lot regulations.

11. The entrance to the parking lot is possible after collecting a parking ticket from the entry machine.
12. The cost of the parking service is included in the parking lot price list.
13. The parking fee needs to be settled at the hotel reception before accessing the vehicle and leaving the parking lot.
14. In order to departure from the parking, a customer needs to scan the previously paid ticket with the exit machine.
15. In case of long-term stays, a customer needs to report to the hotel front desk on a day of the arrival with the entrance ticket.
16. The hotel staff might refuse the parking service in case of the lack of free parking spots.
17. The parking fee is charged by the parking ticket which includes the date and the time of the entrance to the parking lot.
18. The fee for the lost / not collected parking ticket is 50 PLN.

Collecting a parking ticket means accepting the parking lot regulations.
